AND AMENDING GOLF COURSE FEES FOR BOTH SUMMER AND WINTER SEASONS

WHEREAS, the operation of the Manatee County Golf Course commenced on January 14, 1977, and Buffalo Creek Golf Course opened December 16, 1988; and

WHEREAS, the Parks & Recreation Department Director has recommended that the fees for both Manatee County Golf Courses be increased in order to provide additional revenues to fund the operations and debt service for both Golf Courses; and

WHEREAS, based upon recommendations and testimony provided by the Parks & Recreation Department Director, the Board of County Commissioners has determined that it is in the best economic interest of the Golf Courses and the citizens of Manatee County to provide certain discounts and privileges for residents of Manatee County as authorized herein; and

WHEREAS, in order to remain competitive with other golf courses, it is necessary to offer discounts and special promotions for golf fees; and that the Board of County Commissioners may approve, through resolution, any additional discounts and special promotions by majority vote on any regular Board Agenda, which shall apply to the period of time specified in such resolution.

NOW, THEREFORE, BE IT RESOLVED BY THE BOARD OF COUNTY COMMISSIONERS of Manatee County, Florida, as follows:

1. As used in this resolution, the following words shall have meaning provided below:

- A. Manatee County Resident or Resident (hereinafter "Resident") means one who has a true, fixed or permanent home in Manatee County and, whenever absent, has the intention of returning to Manatee County. The genuineness of the intention to return to Manatee County must be manifested by an ongoing physical presence together with indicia that his/her presence is something other than merely transitory in nature. Two of the following must be provided to qualify as a resident:

1. A sworn affidavit declaring that the affiant has established a permanent home in Manatee County and the address or location of the home.
  2. A permanent Florida drivers license with a Manatee County address. Florida only drivers license is not valid.
  3. A Manatee County voters registration card.
  4. A Manatee County homestead exemption certificate.
  5. A Manatee County property tax receipt.
- B. A student means a person enrolled full time in a vocational school, public school or college located in Manatee County. Official documentation from the school, which may include student identification cards, must be presented to establish student status.

II. The rate schedule adopted by the Board of County Commissioners in open session on September 26, 1991, under Resolution R-91-230, and any other resolution in conflict with this resolution, shall be rescinded as of 12:00 A.M. on September 12, 1994. Immediately thereafter, this resolution, including all rules, policies and regulations provided herein and the rates and charges established in Exhibit A, and this resolution shall be in effect.

III. The following rules, policies, and regulations shall govern the applicability and enforcement of the rates and charges established by this resolution.

- A. League rates apply to members of not-for-profit associations organized for the purpose of promoting organized golf at the Manatee County and Buffalo Creek Golf Courses and whose by-laws have been accepted into the records of the Board of County Commissioners and designated as eligible for league rates. Terms, scheduling and conditions for league play shall be in accordance with procedures approved by the County Administrator and/or designee, this resolution and supplementary policies established by the Board of County Commissioners. To be eligible for the Resident League rate all members must have a current Manatee County Resident Identification Card. All holidays take

precedence over scheduled league play. (Holidays defined: New Year's Day, Martin Luther King, Jr. Day, Memorial Day Observance, Independence Day, Labor Day, Veteran's Day, Thanksgiving Day, Christmas Eve, and Christmas Day.)

- B. Privilege card rates are applicable to players holding a privilege card issued by a not-for-profit organization pursuant to an agreement with the Board of County Commissioners. Agreements for privilege cards will be authorized in accordance with the terms of this resolution based upon a determination that such agreements will serve the public interest and promote play during the summer season.
- C. Reservation of the golf courses for a Special Event Tournament is only available from May 1st through October 31st for a fee of \$2,520.00. A 50% deposit will accompany the Special Event Tournament Application. Five (5) days prior to the event, the remainder of the fee will be due. Failure to provide the remainder of the fee will result in cancellation of the event and refund of the deposit minus a 10% handling charge. These events will have an 8:00 A.M. shotgun start with a maximum of one hundred forty-four (144) players. In the event of inclement weather after the majority of the participants have finished nine (9) holes the tournament will be considered completed.
- D. Pre-paid tee times may be purchased up to four (4) months in advance for a minimum of sixteen (16) or maximum of sixty-four (64) players, per day, available May 1st through October 31st. Pre-paid tee times will be offered from 10:00 A.M. to 2:00 P.M.. A 10% non-refundable deposit will be required to secure the reservation. Payment in full is required four (4) days prior to the scheduled tee time reservation. Should the reservation be cancelled after full payment has been received, a 90% refund will be processed. The fee will be \$17.00 per player plus applicable sales tax.

E. Resort Tee Time Deposit: Resorts may establish a holding account by depositing a minimum of \$750.00 plus applicable sales tax. Redeemable by their guests with a Resort Voucher for a fee of \$15.00 per player plus applicable sales tax. Resort Tee Times will be offered from 10:00 A.M. to 2:00 P.M., May 1st through October 31st. After October 31st, the balance in the Resort Holding Account will be refunded to the Resort.

F. All applicable taxes, including sales taxes, imposed by the State of Florida shall be added to the above charges. The County Administrator or designee (s) are authorized to accept reservations for tee times three (3) days in advance from valid Resident I.D. card holders and two (2) days in advance from a non-resident.

This resolution is subject to such supplemental policies, rules and interpretations as may be adopted or provided by the Board of County Commissioners. The County Administrator and/or designee is authorized to develop or approve procedures required to implement this resolution.
